The Foundation received funds as a fiscal sponsor from Bloomberg Philanthropies for the City of Albuquerque in order to create and support an innovation team (or "i-team") that functions as an in-house innovation consultancy, moving from one city priority to the next. In particular, the i-team uses the "Innovation Delivery" approach, supporting agency leaders and staff through a data-driven process to assess problems, generate responsive new interventions, develop partnerships, and deliver measurable results in accordance with the requirements of the grant. The funds are housed and monitored by Nusenda Foundation, who works in partnership with the i-team to fulfill the terms of the grant which is focused on economic opportunity.

These funds are awarded to eligible charitable entities through the Foundation.
