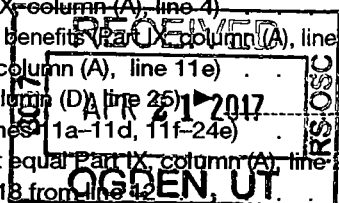

Asociación SERES works with marginalized youth in Central America's Northern Triangle, primarily in Guatemala and El Salvador, who are at-risk of migrating. Asociación SERES offers programs in youth leadership development and sustainability education, helping provide young people with the skills and tools to stay at home and build healthy, sustainable communities. This grant, awarded in August 2016, was to support and train 250 youth from low-income peripheral and rural communities through 6 community congresses, 1 youth facilitator training and 1 youth camp.

Service agreement to Asociación SERES
