The UNFCU Foundation grant requests from the public during the month of June. It processed and reviewed over 65 grant applications during the period. The Foundation approved 11 non-profit organizations and funded a total amount of \$389,500 for programs working to eliminate poverty such as UNWG Project Balsam in Turkey, Khaled Hosseini Foundation - Khurassan Learning Center in Afghanistan, Floating Hospital Mental Health Program for homeless women in Queens NY, Village Enterprise -Expansion of Microenterprise Development Program in Northern Uganda, KCA -Alive Medical Services Program in Kampala Uganda, UN Foundation -Girl Up - Action for Adolescent Girls Program in Guatemala, UNFPAs Fistula Program in Nigeria, Trickle Up Economic Empowerment Program for 125 Qeqchi Women in Guatemala, Kilimanjaro Initiative Youth programs that promote non-violence in Nairobi Kenya, LIC YMCA Summer Programs for 70 at risk youth, Batey Relief Alliance Training Programs for 100 women in bateys areas in Dominican Republic. UNFCU Foundation donated \$10,000 to The Floating Hospital, specifically to underwrite costs related to the renovation and supply of the new educational area, Tania Chan Service Learning and Discovery Room. In response to the humanitarian crises in Haiti, conducted an online fundraising campaign from 21 October through 30 November 2016, with all proceeds (\$24,684) benefiting women and children residing in parts of Haiti most affected by the Hurricane Matthew. Proceeds raised through the 2015 fundraising campaign in support of the Syrian Refugees crisis were distributed to UNHCR for the Lifeline Program in Jordan benefiting Syrian Refugees (\$37,505). On March 24th, at the UN Commission on the Status of Women conference, hosted a Panel Discussion on Effective Partnerships, Alleviating Poverty Through Healthcare and Education. In the second quarter organized and hosted live, on line, two webinars: Microsavings Programs, Best Practices to Alleviate Extreme Poverty and Revolutionizing education in the developing world.
