ON JULY 22, 2014 THE SAN FRANCISCO BOARD OF SUPERVISORS TRANSFERRED THE DEFUNCT FRANCISCO RESERVOIR FROM THE SFPUC TO THE RECREATION & PARK DEPARTMENT TO CREATE A NEW PUBLIC PARK FOR SAN FRANCISCO. SINCE THEN THE FRANCISCO PARK CONSERVANCY WAS CREATED AND APPLIED FOR AND RECEIVED TAX EXEMPT STATUS. THE BOARD OF THE FPC HAVE CONTRACTED WITH AN ARCHITECTURAL FIRM, A CIVIL ENGINEERING FIRM AND A LANDSCAPE ARCHITECTURAL FIRM TO FACILITATE THE CREATION OF THE PARK. SOIL TESTING HAS BEEN DONE AS WELL AS TOPOGRAPHICAL SURVEYS THAT WILL BE USED BY THOSE ARCHITECTS AND ENGINEERS IN DESIGNING AND DEVELOPING THIS PARK.
