Professional evaluations of homes on a sliding scale for 569 families including the identification of significant structural and safety problems, environmental issues (including exposure to asbestos, lead and radon) and critical maintenance needs. Created a free radon testing program for low and moderate income families in Oregon and Washington in an effort to identify elevated levels of radon in the home (the leading cause of lung cancer for non-smokers, and a significant contributor to lung-cancer for smokers).

Further established an educational training program designed to empower others to help identify significant hazards in housing; including job training, an apprentice program and economic opportunities for historically disadvantaged individuals and veterans. Three students started training and 100% of these students passed their state licensing exams. In addition, one employee completed training, and was licensed.

Analyzed energy efficiency defects and gave recommendations for potential improvements in more than 500 homes. Continued development of a solar panel program for low-income families.

The total amount of salaries paid for 2016 was \$135,468, including the last payroll cycle.
