The organization will pursue its charitable objectives through: 1. Awareness building among low income, low education level, or unemployed residents providing access to resources, and non-English speaking programs; 2. Training and support which will include hosting accelerator programs for selected individuals aspiring to launch a new business or nonprofit; 3.
