Imi Pono no ka Aina is an environmental education and outreach program that reached 1,097 people in 2016 via student enrichment activities, native Hawaiian forest restoration service learning trips, and education and outreach at community events. Four grants totaling \$233,655 were received to support these activities, and no program revenue was generated.

Hawaii Nei is an annual juried art exhibition to promote and feature native species of Hawaii Island. Artists of all ages and skill levels are encouraged to learn more about native plants and animals and depict these species in the media of their choosing.

The exhibition features works from elementary students to renowned local artists and is open for public viewing for one month.

The program reached 785 people in 2016 via the art exhibition and its associated events including art hikes, school art presentations and workshops, exhibit tours, and school activities.

The Kauluwehi program promotes native forest engagement and awareness through hands on workshops and events that incorporate Hawaiian culture and native species. Through lei and wreath making workshops participants visit native forests, learn sustainable picking practices, decontamination techniques to prevent invasive species, and work with cultural practitioners. Ten workshops were held in 2016, and 547 people participated.
