Provide groceries to needy families in an atmosphere of dignity. We aim to be transformational rather than transactional lifting, spirits in addition to filling stomach's. We provided over 139,000 pounds of food and groceries to 7526 people during 2869 family visits. Food distributions included 27,000 pounds of fresh produce and almost 15,000 pounds of meat and dairy having very positive impact on the health of our guests. We distributed complete Thanksgiving baskets including whole turkey, fresh potatoes and pies to 220 families feeding well over 640 individuals. We provided simple recipes so our guest could incorporate healthy foods into their meals. We also distributed clothing, household goods, backpacks, Easter baskets, hats and mittens, and Christmas gifts to families who did not have gifts for their children. We connected our guests through 1000's of referrals with other agencies to meet other crucial needs. Provided limited cash assistance to individuals for utility or rental assistance. We facilitated the delivery of an automobile to a single mom so that she could get a better paying job to support her two children.

Our focus on stewardship enabled us to send out \$5 of food for each dollar spent of monetary donations.
