Because of this, they are especially interested in strengthening pastor's wives and children to help them flourish in their ministry roles. Additionally, Relationship Care focuses on strengthening emotional and cultural vitality and emphasizes the importance of friendships in the life of a Christian leader. Rest Care: Based on God's command to "remember the Sabbath" (Exodus 20:8), Rest Care is focused on strengthening Christian leaders and their families through times of rest.
