The Pan Florida Challenge (PFC) funded over 1.44 million meals to feed hungry children. 1.17 million of those meals were served to children in south Florida, during the 2016-2017 school year. The PFC received \$780,442 in contributions and grants and had \$548,045 expenses in fiscal year 2016. The PFC Power Packs (trademarked) are child friendly meals that meet or exceed the USDA recommendations for calories, carbohydrates, and protein. The PFC purchased \$174,696 in meals in 2016, made grants for food totaling \$41,470 and has \$281,250 cash reserved for food purchases.
