1) OPM courses: each OPM course consists eight two-hour lessons on eight consecutive Saturdays. There were a total of four OPM courses in 2016 with total of 52 students. Each student attending an OPM course is charged one \$20 seat fee for the 8-week course. Each student of an OPM course can learn the basic concepts of OPM and its practices; he can learn how to use OPM to treat most pain and aches and ease such pain and aches; he can learn how to live a life style that can prevent pain and ache and lessen the need of medical intervention from healthcare providers.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

2) OPM demonstration and experiences. Any OPM students or anyone from the community may experience OPM at CCH-OPM INC. OPM service is provided by volunteers free of charges. Each OPM treatment session is about 10-30 minutes long, which may include consultation, pressing/vibrating on certain body parts (mostly on one's back) by OPM volunteers. Many visitor, who were treated by OPM volunteers recover from their pains and suffering. They regain their ability to live normal life. Many of them become OPM volunteers to spread the benefits to others.
OPM regular service is on every Saturday afternoon, 3-5pm, serving 20-40 people.
Special OPM service is provided on Tuesday and Thursday afternoon, 2-4pm, serving 5-10 people each day.
In 2016, OPM volunteers treated more than 1000 people/times, most of them are seniors.
