**Supplemental Information for Part III and Part IV**

The organization's primary purpose remains as last year, to provide financial assistance to wheel chair bound veterans, who cannot drive,  
that must be transported in a medically equipped van to their medical appointments at the Veterans Administration medical center in Salem,  
Virginia. This year, we have helped approximately six veterans with this assistance in the total amount of \$3814.00, which is the figure  
recorded on line 30, Part III.

Expanding the organization's mission this year, we have been able to provide modest financial assistance to veterans living well below the  
poverty level with help with rent, heating, food, house maintenance, medical expenses, homelessness, the list goes on. The figure on line 28  
of Part III of \$8002.00 is what was distributed in 2016 in this program.

Publicly supported events were conducted this year where funds raised were distributed to other exempt veteran organizations that partner  
with the Lynchburg Area Veterans Council, Inc. Specifically, the Military Order of the Purple Heart, Vietnam Veterans of America, chapter 196,  
American Legion Post 16 Lynchburg, and Rolling Thunder Chapter 4 Lynchburg Virginia, received donations from the public which "flowed  
through this organization. The figure on Line 29, Part III of \$11,375.00 represents the grants through this program.

The total expenses for the organization for tax year 2016 were \$8515, reported on Line 15 at \$1590.00 and Line 16 at 6925.00, totaling \$8515.

The Line 15 figure of \$1590 represents office expense, postage, printing, filing fees, bank fees, etc.

The Line 16 figure of \$6925 primarily represents the insurance that the organization maintains; an umbrella \$1,000,000 liability policy for the  
organization, a Directors and Officers insurance policy protecting all of the officers and directors of the organization, and a surety bond  
insurance policy on our treasurer and others that are authorized to sign checks. Another major portion of this expense is the printing cost  
for posters and flyers for our fund raising events.

The total expenses for the organization really apply across the board for all of the programs undertaken during 2016. Line 32, Part III records  
the total of the expenses for the year in the amount of \$8515.00. It would be meaningless to spread this expense figure across the three  
major programs listed in Lines 28, 29, and 30.
