Grants and other assistance intended to promote academic excellence is targeted in several areas including, the recruitment, retention and reward of exceptional school leadership and teachers, providing state of the art information technology including equipment and training, monitoring student achievements through academic assessment programs and providing forums for school leadership and teachers to come together to share ideas, common issues and lessons learned. Working in close collaboration with the 79 Catholic preschools and elementary schools within the Archdiocese of St. Paul and Minneapolis, the Catholic Schools Center of Excellence has been successful in helping raise the academic performance of these schools to a clearly superior level always within the parameters of a clearly Catholic spirituality.

To achieve the second part of its dual mission, enrollment growth, the Catholic Schools Center of Excellence has provided grants and other assistance to the 79 Catholic preschools and elementary schools which it supports in areas including preschool development, nurturing and growth, tuition assistance, bussing assistance and marketing and advertising assistance. Working in collaboration with the schools, the organization's success in meeting its goal of enrollment growth has been immediate and remarkable - after several decades of significant declines have been halted and total enrollment for the 2016-17 academic year showed a modest increase.
