IN 2016, THE UTAH LEAGUE EXPERIENCED A 46% GROWTH IN STUDENT ATHLETE PARTICIPATION. WE HAD 2393 STUDENTS PARTICIPATING ON 81 INTERSCHOOLASTIC TEAMS ACROSS THE STATE OF UTAH, WITH 854 LICENSED COACHES. TEAMS LEARNED MOUNTAIN BIKE SKILLS, HELD REGULAR TEAM PRACTICES, PARTICIPATED IN TRAIL WORK IN THEIR COMMUNITIES, AND COMPETED IN NINE CROSS COUNTRY MOUNTAIN BIKE RACES DURING THE FALL. OUR 2016 THEME, "BE THE ONE" ENCOURAGED ALL AFFILIATED WITH OUR PROGRAM TO MAKE A DIFFERENCE. "ALL IT TAKES IS ONE, TO MAKE A DIFFERENCE. ONE COACH. ONE ATHLETE. ONE TEAM. ONE VOLUNTEER. BE A PART OF SOMETHING TO CHANGE YOUR LIFE, AND CHANGE SOMEONE ELSE'S. BE THE ONE WITH IMPACT, INSPIRATION, AND ACHIEVEMENT. YOU CAN MAKE A DIFFERENCE IN 2016." THE UTAH LEAGUE STARTED "STUDENT LEADERS SUMMIT" EVENTS TO TRAIN TEAM CAPTAINS IN LEADERSHIP SKILLS SO THEY COULD MAKE A POSITIVE DIFFERENCE ON THEIR TEAMS. WE ALSO EXPANDED OUR ELEVATE PROGRAM FOR DISABLED STUDENTS BY PARTNERING WITH THE NATIONAL ABILITIES CENTER IN PARK CITY. ADDITIONALLY, WE PROVIDED SCHOLARSHIPS AND LOANER BIKES FOR 60 STUDENTS IN NEED TO BE ABLE TO PARTICIPATE IN OUR PROGRAM. LASTLY, THE UTAH LEAGUE PROVIDED COACHES THE TRAINING AND EDUCATION THEY NEED TO BECOME NATIONALLY LICENSED COACHES. WE HOSTED NINE LEADERS SUMMIT'S AND NINE FIRST AID CLINICS IN 2016 FOR COACHES.
