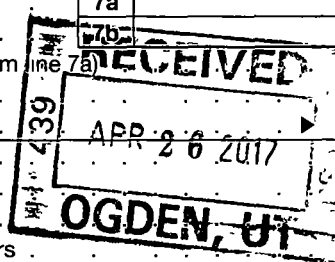

Form 990-EZ, Part 3, Lines 28-31: The accomplishments in the first year of operations include organizing the programs, recruiting adult candidates to serve as mentors and recruiting appropriate youth for the programs. We developed specific training programs for our mentors and required all adults to submit to state and federal fingerprint background checks to be considered for the programs. In year 2017, we are launching the actual programs and will be seeking money to fund them. The largest grant we received was from Wells Fargo (see sched B), and that was designated by the donor to be used for Operating Expenses, and we haven't used it yet. It's still in the bank.

Form 990-EZ, Part 4: We have launched Age-Out Angels as an all-volunteer organization. We do plan to compensate some specific positions in the future, but not for the first two years.
