The Leavenworth Interfaith Shelter of Hope provided temporary shelter for 233 individuals during 2016. The shelter provided 4675 nights in a safe and climate controlled environment for individuals and families who would otherwise have slept on the streets.

The Welcome Central served 409 individuals resulting in 805 referrals to other government and private agencies, as well as assisting with job searches, filling out government agency forms, and obtaining birth certificates and government identification cards. It provided transportation support to essential services on 3744 occasions covering 21,526 miles. It served as the distribution organization for thousands of dollars of donated food.
