DURING THE YEAR 2016, PRIESTS FROM THE ARCHDIOCESE OF TORORO IN UGANDA, CAME TO THE USA AND SPOKE AT VARIOUS CATHOLIC CHURCHES TO WHICH THE ARCHDIOCESE OF TORORO HAD BEEN INVITED, IN THE CATHOLIC DIOCESES OF Boston MA, Buffalo NY, Chicago IL, Cincinnati OH, Colorado Springs CO, Detroit MI, Fort Worth TX, Louisville KY, Monterey CA, New Orleans LA, Omaha NE, St Augustine FL, St Louis MO, Syracuse NY, Tulsa OK, El Paso TX, Raleigh NC ETC. THEY RAISED ABOUT \$180,000. MOST OF THIS MONEY WAS DISBURSED TO THE ARCHDIOCESE OF TORORO IN UGANDA FOR ITS SOCIAL AND SPIRITUAL WORK. ALSO A MAIL CAMPAIGN AT CHRISTMAS TIME TO VARIOUS DONORS CONTAINING A DESCRIPTION OF THE WORK OF THE ARCHDIOCESE OF TORORO THROUGHOUT THE YEAR GENERATED ABOUT \$110,000.
