 GrantmakingGroundswell Fund supports approximately 40 organizations across the United States. Our grantmaking focuses on bolstering and scaling organizations that are building a grassroots base of support for reproductive justice (RJ) policy and systems change, on organizations that are reducing poor birthing outcomes by expanding access to community-based midwifery and doula care. We acknowledge that systems change takes time. Thus, the vast majority of our grants are for general support, and we commit to funding efficient and effective organizations over many years. We award grants through three funds (below), and through our capacity building programs. Click icons below for more information on each fund.

 Capacity BuildingThe underlying principle of our capacity-building work is that all programs are opt-in for grant partners, and organizations will not be required to participate in these programs to receive other grant support. Interested organizations may apply to be considered for specific capacity building programs, which currently include: (a) Integrated Voter Engagement, (b) Grassroots Organizing Institute, (c) Income Diversification, and (d) Organizational Development.

 ECOSYSTEMIn 2016, Groundswell Fund launched a new initiative to accelerate RJ policy and systems change in particular cities and states by deepening support for existing grantees and their key allies (such as economic justice organizations) within local and state ecosystems. Ecosystem states currently include Florida, Georgia, and Colorado. Groundswell will layer funding, capacity-building resources and other support more deeply in specific ecosystems where we already have strong grantee organizations to catalyze power building, movement-building and policy change.
