28 Refugees Thrive raised funds this year through directed e-mails to mailing list subscribers. We dispersed \$5,000 to our operating partner, St. Andrew's Refugee Service, in accordance with their 2016 funding proposal. This covered legal, educational, and psychosocial services for refugees living in Egypt. St. Andrew's serves over 20,000 refugees a year. Their clients are from Syria, Sudan, South Sudan, Ethiopia, Eritrea, and Somalia, among other places. Our major donor this year was Bono - he contributed \$47,000 at the end of the year. St. Andrew's has proposed to use those funds to cover two college scholarships for Syrian refugee staff and legal, psychosocial, and educational services for their clients. We have not yet dispersed these funds because we have been going back and forth on the proposals. We expect to disperse those funds in April 2017.
