We are working with a local veterinarian for the medical needs necessary for each pet, ensuring that each pet is spayed, neutered, vaccinated, and given a well check before placing into foster care. These consisted of a disaster preparedness event hosted by a local big home improvement store and our city fire department, an open house at a local fire station, an annual city safety event, a grand opening at a local pet veterinarian, as well as hosting our own adoption event held at a local pet store where other rescue organizations were invited. In total we estimate from these events that 500-700 people were benefited. Through an alliance with a certified trainer, we have offered pet CPR and first aid classes on a quarterly basis, where we had approximately 60 students sign up and become certified. We have held several pet care and awareness classes, including over 45 students between the grades K-2, and adult learning center with 40 students, an animal club with over 35 present.
