This year we sponsored a local startup, Checkmate Creations, providing an in-kind donation of coworking space to the digital startup for the year. They have grown from three graduates coming from a local Quinnipiac University. We managed to keep them in our local region which is renowned for brain drain by providing them with coworking space to test out their ideas for business in the real world, so that they could succeed.
