Identified Kickapoo Park (formerly Prince Hall) and surrounding areas as the first target neighborhood to establish a Friendship House due to an elevated level of criminal activity. Friendship House efforts in high crime neighborhoods in Shreveport (Community Renewal International) have reduced crime on average by over 50% in a twenty-year period.
