EXPLANATION OF LATE FILING

The Foundation requests that any penalty for late filing of Form 990-PF be abated under reasonable cause. The main Trustee of the Foundation relocated from the United States to the United Kingdom in 2015 and changed tax preparer as a result of his relocation. The Trustee appointed a new tax preparer based in the United Kingdom which understood that the previous tax advisor in the United States would be taking care of the filings for the Foundation and vice versa. As soon as the Trustee became aware that the return had not been filed he engaged Deloitte LLP in the United Kingdom to prepare the return and has settled the tax due.
