Rosedale Healthy Kids - community based collaborative effort to support healthy living in the Rosedale neighborhood. Accomplishments include: organized community events including a bicycle rodeo, bike-in movie, RISE, International Walk to School Day and Healthy Halloween; sent 54 students to weeklong overnight summer camp; operated community bike workstation for free bike repairs to community; maintained 4 miles of natural surface walking trail (Rozarks); supported access to healthy food through 5 community and schoolyard gardens and the Rosedale Farmers Market. Collaborated with Healthy Communities Wyandotte Initiative. Expanded participation in youth programs, community gardens and community walking club.

4b (Code) (Expenses \$ 13,546. including grants of \$ 0.) (Revenue \$ 0.)

Youth Programs - Provided services and education for over 1,500 area youth through 25 programs and events. Programs included Summer Youth Employment, Excellence in Education, Youth Sports leagues, Walking School Buses, and community and schoolyard gardens.

4c (Code) (Expenses \$ 65,652. including grants of \$ 0.) (Revenue \$ 2,310.)

Community Outreach - provided a variety of resources to over 14,000 of the area's residential business and institutional community members including social services, crime reduction, improvement of housing stock and urban planning. Convened 250 unduplicated community members for a community-based participatory Master Planning process and participated in Rosedale Master Plan Update Advisory Committee. Responded to dozens of crime and code related issues, development issues and thousands of calls, emails and social media interactions and messages requesting service/information. Provided minor home repairs to 12 families and referred additional families to other agencies for major home repairs. Organized monthly meetings of Rosedale Leadership Council and supported the launch of a new neighborhood group. Served 46 families through the Feed a Family program, which provides baskets of food, household supplies and winter children's clothing to area families. Recruited over 350 volunteers who gave over 2,000 hours of community service.
