IT IS IMPOSSIBLE TO QUANTIFY THE NUMBER OF LIVES SAVED, THE VIOLENT ACTS AVOIDED, OR EVEN THE SENSE OF PEACE AND SECURITY PROVIDED. THE ORGANIZATION PROVIDES DAILY MEALS, CLOTHING AND PERSONAL ITEMS, AND A PRIVATE HOTEL-LIKE ROOM, WHERE WOMEN AND CHILDREN CAN BEGIN THEIR RECOVERY. ALL SERVICES ARE PROVIDED FREE OF CHARGE.

 COUNSELING VICTIMS OF DOMESTIC VIOLENCE NEED MORE THAN A SAFE PLACE TO SLEEP. THEIR WORLDS HAVE BEEN TURNED UPSIDE DOWN THROUGH EMOTIONAL, ECONOMIC, PHYSICAL AND SEXUAL ABUSE. IN 2016, THE ORGANIZATION'S 8 FULL-TIME AND 3 PART-TIME LICENSED PROFESSIONAL THERAPISTS, WITH THE HELP OF 20 INTERNS, PROVIDED 1,262 PEOPLE WITH 10,768 HOURS OF COUNSELING. THE ORGANIZATION ALSO MAINTAINS A 24/7/365 CRISIS HOTLINE WITH TRAINED PERSONNEL TO RESPOND TO CALLERS SEEKING HELP. THE ORGANIZATION ALSO HAS AN EDUCATION & PREVENTION TEAM THAT PROVIDES COMMUNITY AND SCHOOL-BASED EDUCATION. IN 2016, THEY PROVIDED EDUCATION ON HEALTHY DATING AND DOMESTIC VIOLENCE TO 12,717 STUDENTS AND ADULTS.
