The Foundation responded to the expressed needs of STFM members for funding research and education by establishing the Group Project Fund, now called the STFM Project Fund, in 2008. This fund encourages groups to collaboratively plan, develop, implement, evaluate, and disseminate findings from educationally related scholarly projects. The outcomes of projects will benefit group members, STFM, and the discipline of Family Medicine.

This is an initiative to address the challenges with recruitment and retention of sufficient numbers of family medicine faculty.

Faculty for Tomorrow will: expand STFM's formal faculty recruiting efforts of residents, provide resources and training for new faculty

including those moving from private practice to family medicine education, identify and support young family physicians with

leadership potential, and ensure leaders of institutions understand the time and competencies required to be faculty.

NEW FACULTY SCHOLARS (Expenses = \$18,187 Grants = \$15,937 Revenue = \$3,025)

Since the inception of the New Faculty Scholars awards in 1988, more than 150 STFM members have received this support. The support is

intended to provide STFM members who are in their first two years as full time faculty and who exhibit outstanding leadership

potential the opportunity to attend the Annual Spring Conference. This introduction to over 1800 STFM members, leads to

community building activities. Three to seven scholarships are awarded annually.

PROGRAM ENHANCEMENT (Expenses = \$8,510 Grants = \$7,760 Revenue = \$600)

The program enhancement award, initiated in 2013 provides funding for family medicine programs to implement enhancements at their
