Payments to providers and minor administrative costs to pay the partial cost of abortion care for Wisconsin women and girls to help ensure economic access to safe, legal abortion care. The Women's Medical Fund helped 782 women in 2016, with an average grant of \$330 paid directly to providers. The average recipient is in her 20s, is already a mother, is unmarried, receives Medical Assistance (which does not cover abortion care), is a high school grad, was not receiving help in paying for the procedure from the man involved, and was less than 12 weeks pregnant. Of the women helped, recently, 37 reported pregnancy from rape, & 119 women reported that the impregnator was abusive. Three-quarters of clients already had at least one child; one recipient of help had 9. Ten percent of recipients were teens, 63% in their 20s, 26% in their 30s and several in their 40s. A majority of recipients also qualified for food stamps. The Fund is seeing an increasing number of women who are homeless, some of whom are bounced from friends to family members, often after eviction, especially in Milwaukee. All funds went directly to help women cover medical costs of abortion care (checks sent to providers), with less than 1% of expenses spent on accounting, banking costs and fees.
