INTERNATIONAL AFFILIATE INSTITUTIONAL MEMBERSHIP STATUS SHALL BE GRANTED UPON REQUEST OF ANY SCHOOL OUTSIDE THE UNITED STATES OR CANADA THAT OFFERS A PROGRAM TO EDUCATE PERSONS FOR THE PRACTICE OF LIBRARY AND INFORMATION SCIENCE AT THE PROFESSIONAL LEVEL AS DEFINED OR ACCEPTED IN THE COUNTRY IN WHICH THE SCHOOL IS LOCATED. ASSOCIATE INSTITUTIONAL MEMBERSHIP STATUS SHALL BE GRANTED TO LIBRARIES AND OTHER ORGANIZATIONS OTHER THAN SCHOOLS OF LIBRARY AND INFORMATION SCIENCE.
