The Gardiner Library Association (the Association) owns the building and the land, makes capital improvements, buys new equipment, and seeks to improve library services. Almost half the new materials of the library each year are purchased with funds provided by the Association.

The City of Gardiner operates the Gardiner Public Library through the oversight of the City Council and with the advisory role of the Gardiner Public Library Board of Trustees. The Board of Trustees is completely separate from the Association's Board of Directors.

The Gardiner Public Library hires and oversees a Librarian who is an employee of the City of Gardiner. The Librarian is an ex-officio, non-voting member of the Board of Directors of the Association. The Librarian attends meetings of the Association's Board and provides information and input to the decisions made by the Board. The 11 independent members of the Board of Directors of the Association vote on all of its operational and financial decisions.
