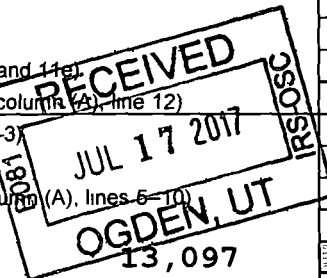

Foundation's Board of Directors (27 voting members) consists of leaders of the community and represents a cross section of views and interests of the area it serves.

Availability of public programs and support - The Foundation's marketing and development programs seek funding from the public on a continuing basis. This is accomplished through a donor base of over 7,500 to which targeted fundraising mailings, newsletters and community outreach announcements are sent. In addition, the Foundation promotes its programs and seeks support throughout the community via its website. The Foundation received contributions from 91 donors in 2016.

Percentage of financial support - This section of the regulations says, "If the percentage of the organization's support from public or governmental sources is low because it receives a high percentage of its total support from investment income on its endowment funds, such fact will be treated as evidence of compliance with this subdivision if such endowment funds were originally contributed by a governmental unit or by the general public." 
