The Tumor Targeting Toxins grant to the University of California, San Diego, funds research directed to the discovery and development of compounds for cancer therapy, including dendrimers with drugs on board, compounds synthesized with proteins joined by a sortase reaction, and compounds with a variety of targeting ligands coupled with toxins for delivery to multiple tumor types. Patent applications have been filed for these technologies, and collaborations have been and are being established with other scientists and with commercial entities and consultants for development of drugs for human cancer indications.

The Characterization of Neuropeptides and Their Receptors grant to The Salk Institute for Biological Studies focuses on investigation of the Corticotropin-Releasing Factor ("CRF") and related neuropeptides signaling network which could lead to the new means of treating stress related and other serious human disorders. Of major importance is identification of the expression of CRF receptors and the urocortins in pancreatic tissue. These studies are setting the stage for novel targets in the understanding and treatment of both type 1 and type 2 diabetes. Part of this technology has been patented and licensed to a small pharmaceutical company for commercial development.

The Characterization of Hormones and Growth Factors and Their Receptors grant to The Salk Institute for Biological Studies focuses on discovering Transforming Growth Factors ("TGF") secreted proteins, their roles and their selective binding to cell surface receptors creating pathways which when disrupted can result in developmental defects and tumor formation. The Clayton Program has facilitated the discovery of several TGF protein family members as well as their receptors, co-receptors, signaling molecules and modulators and provided opportunities for the identification of therapeutic targets. Part of this technology has been patented.
