INAgLaw seeks to further the understanding of agricultural legal issues within the agricultural community, and the judicial branch of government. This past year INAgLaw supported cases involving standing in agricultural zoning cases, annexation, Indianas partition fence law, Indianas right to farm law, IDNRs duty to maintain lake levels, public trust doctrine in Indiana and general private property rights.

INAgLaw supports educational programs that deal with legal issues facing farmers. Estate and succession planning impacts every farm in the State of Indiana. INAgLaw recognizes the important role the Foundation can play in educating farmers in this area. July 20, 2016 marked the third installment in an annual series developed by the INAgLaw geared towards educating Indiana farmers on estate and succession planning issues. CLE credit was offered to attending attorneys. Presenters highlighted the importance of communication among family members, the role of attorneys and accountants in the succession process as well as agricultural land value trends. INAgLaw facilitated events to educate landowners on legal issues associated with utility easements and rails to trails programs. INAgLaw co-sponsored Indiana Farm Bureaus Drainage School and The American Agricultural Law Associations annual meeting in Oklahoma City.

INAgLaw provides financial support in developing publications that assist farmers and others in understanding critical legal issues affecting agriculture. INAgLaw created a publication detailing landowner considerations in evaluating utility line easements impacting their property. Also, INAgLaw produced articles educating Indiana corn growers on the national class action lawsuit against Syngenta which impacts every corn farmer in Indiana. Publications pertaining to the current status of the common law of private property and agricultural employment law were either created or updated this year as well. The INAgLaw continues to publish a monthly newsletter, The Spotlight, which contains articles on current legal issues impacting Indiana agriculture.
