FOUNDATION RESEARCH FINDINGS ARE USED TO SUPPORT NATIONAL PUBLIC AWARENESS CAMPAIGNS, SUCH AS GLOBAL YOUTH TRAFFIC SAFETY MONTH, NATIONAL TEEN DRIVER SAFETY WEEK, AND DROWSY DRIVING PREVENTION WEEK. THEY ARE ALSO USED TO DEVELOP EDUCATIONAL MATERIALS, AND SUPPORT ADVOCACY EFFORTS OF AAA AND OTHER TRAFFIC SAFETY ADVOCACY ORGANIZATIONS. ALL OF THESE EFFORTS ARE ULTIMATELY DESIGNED TO INFLUENCE AND AFFECT REAL WORLD IMPROVEMENTS IN TRAFFIC SAFETY. FOUNDATION RESEARCH HAS ALSO SUPPORTED OUR NUMEROUS PARTNERSHIPS IN THE TRANSPORTATION AND SAFETY COMMUNITIES. WE CONTINUED TO SUPPORT THE UN DECADE OF ACTION FOR ROAD SAFETY, AND ITS TOWARD ZERO DEATHS VISION, AND OTHER NATIONAL STRATEGIES, CAMPAIGNS. WE ALSO PARTICIPATED IN AN EXPERT WORKSHOP CONVENED BY THE NATIONAL SAFETY COUNCIL TO HELP TO INFORM EFFORTS TO COMBAT WORKPLACE ACCIDENTS ASSOCIATED WITH FATIGUED WORKERS, AND HOSTED A MULTIPLE MEETINGS OF KEY INDUSTRY STAKEHOLDERS ON TOPICS INCLUDING THE DEVELOPMENT OF A PLAN TO IMPROVE NATIONAL DATA ON DRUGGED DRIVING, AND THE BENEFITS AND COSTS OF ADVANCED SAFETY TECHNOLOGIES FOR LARGE TRUCKS. FINALLY, IN 2016 WE INITIATED RESEARCH PROJECTS DESIGNED TO ADDRESS THE CRASH RISK ASSOCIATED WITH USING A CELL PHONE WHILE DRIVING, THE POTENTIAL SAFETY BENEFITS OF ADVANCED SAFETY TECHNOLOGIES FOR LARGE TRUCKS IN RELATION TO THEIR COSTS, ADAPTING DRUNK-DRIVING COUNTERMEASURES TO USE TO COMBAT DRUGGED DRIVING, THE SAFETY BENEFITS OF INVESTMENT IN HIGHWAY SAFETY INFRASTRUCTURE, THE EFFECTIVENESS OF PROGRAMS FOR PARENTS OF NEW TEEN DRIVERS, COMPREHENSIVE MEASUREMENT OF DRIVER DISTRACTION ASSOCIATED WITH NEW IN-VEHICLE TECHNOLOGIES, AND DEVELOP TRAINING FOR JUDGES AND PROSECUTORS ABOUT THE LATEST SCIENCE ON DRUGGED DRIVING.

ALL BROCHURES ARE ALSO OFFERED ELECTRONICALLY ONLINE FOR FREE, AND THE FOUNDATION OFFERS OTHER ONLINE EDUCATIONAL TOOLS, SUCH AS ROADWISE RX, FOR FREE AS WELL. ADDITIONALLY, THE AAA FOUNDATION DISSEMINATES ITS RESEARCH FINDINGS AND SAFETY MESSAGING TO KEY STAKEHOLDERS AND THE GENERAL PUBLIC, WITH THE GOAL OF EFFECTING REAL-WORLD CHANGE. IN 2016, FOUNDATION RESEARCH FINDINGS WERE PRESENTED AT NUMEROUS CONFERENCES AND EVENTS, SUCH AS THE ANNUAL MEETINGS OF THE GOVERNORS HIGHWAY SAFETY ASSOCIATION, TRANSPORTATION RESEARCH BOARD, LIFESAVERS CONFERENCE, NEW HAMPSHIRE TRAFFIC SAFETY CONFERENCE, AND PHILADELPHIA VISION ZERO SYMPOSIUM. LAST YEAR ALSO SAW RECORD MEDIA COVERAGE OF FOUNDATION RESEARCH, WHICH INCREASED BY 13% OVER 2015, WITH AN ESTIMATED BROADCAST AUDIENCE OF OVER 548 MILLION. THE FOUNDATION'S WEBSITE CONTINUES TO BE A CONSUMER-FRIENDLY, ONE-STOP SHOP FOR FOUNDATION RESEARCH, COLLATERAL MATERIALS, EDUCATIONAL PRODUCTS, AND MULTIMEDIA OFFERINGS. ALL IN ALL, THE FOUNDATION MAINTAINS 5 WEBSITES THAT RECEIVED MORE THAN 320,000 SESSIONS LAST YEAR.
