The assessment of the tax position is based solely on the technical merits of the position, without regard to the likelihood that the tax position may be challenged. The adoption of ASC 740-10 did not have a material impact on NSSLHA's financial statements, as management determined that there are no uncertain tax positions within its financial statements.
