Facts And Circumstances Test

The Indian Law Resource Center works throughout the year to raise funds from individuals, tribal governments, and private foundations. The Center does not receive a majority of its funding from a single institution or donor in any given year. While the bulk of the organization's funding currently comes from eight private foundations, the Center also receives roughly 250-300 donations each year from individuals, small family foundations and Indian nations. These donations, which range from \$2 to \$50,000, are usually in response to appeal letters or other online fund raising campaigns directed at the public audiences we work to inform and cultivate on a regular basis during the year. The Center also participates in and receives support from an (unknown) number of civil servants and other government workers through public employee charitable giving campaigns. The Center is committed to providing legal and advocacy assistance to Indian nations and organizations free of charge, regardless of ability to pay, and thus is not a membership-based organization. The Center accepts contributions and applies for grants from Indian nations and tribes, but it does not request nor accept support from any other governments or governmental entities in the United States or abroad. This policy is in place to ensure the Center remains independent and is not reliant on funding from sources that could limit or undermine the organization's ability to challenge government policies, actions and laws that discriminate against or infringe on the rights of Native American peoples. The Indian Law Resource Center is governed by a 12-member board of directors. Nearly all of the directors are American Indian/Alaska Native/indigenous professionals with direct experience working for or with tribal governments. They include elected, hired, and appointed leaders and representatives. Although they do not serve on the Center's board as representatives of a particular community, their experiences living in and serving a geographically and culturally diverse range of Indian communities provide valuable perspectives that affirm the Center's legal and advocacy services not only benefit the communities the organization works with but also respond to the broader, underlying needs and interests of indigenous communities across the Americas.
