Supported the marine chemist certification process which includes a comprehensive training program, which must be completed in six years, initial certification and recertification every five years. Initial certification requires a trainee to meet extensive educational, professional and general requirements and to satisfactorily complete an examination of the Standard for Control of Gas Hazards on Vessels as well as all applicable U.S. Coast Guard and Occupational Safety and Health Administration (OSHA) regulations and other technically related or appropriate standards, rules and regulations. Certification qualifies the marine chemist to determine whether construction, alteration or repair of all types of marine vessels and facilities can be safely undertaken.

The Marine Chemist Qualification Board certifies all individuals as Certified Marine Chemists.

Approximately 99 marine chemists served.

Supported advancement of marine chemists' professional qualifications through attendance at educational/technical seminars which provide a forum for disseminating information on current rules and regulations, for an exchange of views, development of professional policies, presentation of technical papers, and interface with personnel in the marine industry. Certified marine chemists are required to attend a designated number of seminars during the period of their certification.
