The custodian credits interest on an accrual basis to each account that holds units of these investment funds. Interest actually received by the funds upon maturity of its investments during a taxable year is allocated to fund unit holders for purposes of Form 1099. Accordingly, unit holders may receive credits for interest that are greater or lesser than the reported interest on Form 1099, depending upon the maturity dates of the funds' underlying securities. As a result, the fair market value of assets, which is not based on the income reported on Form 1099 but on the income credited to the custodial account, may be greater or lesser by a like amount.
