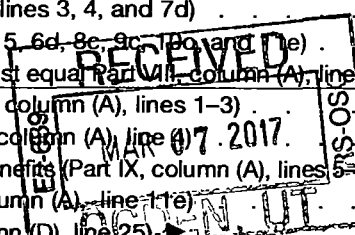

To broadcast 24/7/365 in the Florida Keys on FM radio (and world-wide on the internet) the good news that God who created us, sustains us, loves us, is able to give us power in our daily lives. To proclaim locally through various types of outreach the message that Jesus is coming soon and it is time to get serious about our relationship with Him.

We lease antenna space on a commercial tower at 460 ft AGL and operate under a FCC Class permit, broadcasting ERP at 12.5 kw. We are a full-power Christian FM radio station which offers music, religious, health and educational programs, through which we are proclaiming God as the answer for life's problems. In 2015 we began broadcasting in Spanish two hours each week day, including religious and character building stories. We also co-sponsor an annual week-end campmeeting where well-known radio speakers and musicians can meet together with local listeners for worship and seminars to learn how to prepare spiritually and physically for the soon coming of Jesus.

We are able to accomplish our goals with the financial help of 450-500 donors, many monthly, and others less frequently. About 4000 interested families receive our bi-monthly newsletter which includes a Not By Accident (but by God's design) nature segment in each newsletter. We are staffed by 1 full-time, 2 half-time and 1 summer intern as paid employees plus 2 part-time contractors for radio programming and one part-time contractor to handle the mailing of the newsletter. Also, 30-40 individuals volunteer each year, some for a day or two, and others who work without pay on a regular basis.
