DEMING. THE DEMING PHILOSOPHY LOOKS AT THE WORLD THROUGH A LENS THAT IS DIFFERENT FROM ALL OTHERS. IT IS A HOLISTIC APPROACH TO LEADERSHIP AND MANAGEMENT THAT BRINGS TOGETHER AN UNDERSTANDING ABOUT VARIATION, THEORY OF KNOWLEDGE, PSYCHOLOGY AND APPRECIATION FOR A SYSTEM.
