 AAPD Summer Internship Program AAPD's summer internship program makes the Washington, DC internship experience available to motivated people with disabilities, developing a new generation of leaders and offering host employers access to a talented, diverse work force. Each summer, AAPD places 10 current and recent undergraduate, graduate, and law students with all types of disabilities in paid 10-week summer internships in Congressional offices, federal agencies, nonprofit and for-profit organizations. AAPD provides accessible housing, a living stipend, and travel to and from Washington, DC for all summer interns.

 THE PAUL G. HEARNE/AAPD LEADERSHIP AWARDS AND GALA - The Paul G. Hearne/AAPD Leadership Awards are cash gifts awarded annually to people with disabilities who are emerging leaders in their fields and have positive visions for the disability community. Each prior awardee is now using their award to further their work in their respective states, as well as nationally, to improve the lives of all people with disabilities. The AAPD Leadership Awards Gala held for the first time in 2002 is an annual forum, pays tribute to disability community leaders, brings together highly diverse constituents, and promotes advocacy. Attendees from around the country include members of the disability community, other key civil rights advocates, the media, corporate representatives, state government and election officials, Members of Congress, Administration representatives and other policymakers. In-kind services and use of donated equipment related to this program totaled \$12,943.

 Public Policy and Research - AAPD's staff work on national disability policy issues and disability-related research projects that advance the goals of the Americans with Disabilities Act: equality of opportunity, full participation, independent living and economic self-sufficiency.  OTHER PROGRAMS INCLUDE Advocacy - The Organization educates elected officials, corporations and businesses, and the general public on nonpartisan issues and policy that will further the ability of people with disabilities to live independently, contribute to society, pursue meaningful careers and enjoy self-determination. AAPD will continue to protect programs and policies that empower children and adults with disabilities and realign programs and policies that erect barriers to full participation. External Affairs - The organization's work and achievements are continually highlighted to our community members, partners, supporters, and legislators. We achieve this goal by creating high quality digital content through print, social, and online media, as well as creating visual content, such as video productions and dynamic graphics. AAPD's website features a daily blog & a quarterly newsletter which serve as ongoing mediums for community outreach. Disability Mentoring Day (DMD) - The Disability Mentoring Day program connects nearly 16,500 students and job seekers with disabilities to thousands of employers each year. The 2014 events took place in over 250 locations across the country. DMD, held the third Wednesday in October, promotes career development through hands-on programs, job shadowing, and ongoing mentoring. This experience has helped thousands of past participants develop lasting relationships and secure internships or jobs. The mission of the AAPD Interfaith Initiative is to support people with disabilities and their families as they seek spiritual and religious access, and to bring the powerful and prophetic voice of the faith community to the 21st Century disability agenda. AAPD contracted with Ginny Thornburgh to be Director of the AAPD Interfaith Initiative in September 2008. She has over 20 years of experience working in the religion and disability field. One of the accomplishments of the program is the founding of the Interfaith Disability Advocacy Initiative (IDAC) which mobilizes the religious community to speak out and take action on disability policy issues with Congress, the President and Administration, and society at large. The Disability Equality Index (DEISM) is a national, transparent benchmarking tool which offers major employers the opportunity to receive an objective score on their disability inclusion policies and practices and identify avenues for continued improvement. It is also intended to help build a company's reputation as an employer of choice. The tool is a joint project with another disability focused organization. Total in-kind services donated for the above programs total \$3,935.
