Turkey: As a follow-up to the 2015 Leadership Training for Turkish NGOs Fighting Against Gender-Based Violence, HasNa Inc. implemented Phase II in November 2016 in association with Muş Kadın Çatısı (a women's rights organization in eastern Turkey) and two trainers who are members of the MenEngage Europe alliance. A 5-day train-the-trainers program was held in Istanbul with eleven participants representing educational institutions, government bodies, and civil society organizations from all over Turkey. The train-the-trainers program drew upon a range of models and influences in exploring how masculinities can be transformed. This was a participatory train-the-trainers that was intended to be more an exchange of ideas and cultural experiences than a series of lectures. Some of the topics touched on included care-giving, gender and socializing, fathering and being fathered, gender-based violence/non-violence, and community mobilization. HasNa also partnered, along with the University of Maryland, with agricultural experts from Southeastern Turkey, to conduct a training program for goat and sheep breeders.

4b (Code:) (Expenses \$ 42,341 including grants of \$) (Revenue \$)

Cyprus: HasNa's proposed Digital Futures Project focuses on involving the public and creating widespread awareness of the current stages of reunification negotiations in Cyprus. To create a shared awareness, HasNa Inc. aims to train 25 youth journalists to interview Cypriots from both sides and publish their responses online. Staff time was used for grant writing and applications as well as for establishing strategic partnerships with local NGOs in northern and southern Cyprus.

Armenia: HasNa and Youth Empowerment and Sustainability (YES), based in Armenia, formed a partnership to launch an annual summer program called Turkish-Armenian Youth Dialogue (TAYD). The goal of this three-week summer program was to promote friendship and understanding between Turkish and Armenian teenagers and to develop their leadership skills. HasNa engaged in various activities to launch TAYD which involved organizing fundraising events; networking with the Armenian-American and Turkish-American communities to raise awareness about this new youth program; preparing application forms for teenagers from Turkey and Armenia; contacting high schools and local NGOs to spread information about TAYD in Turkey and in Armenia; looking for host families in Washington DC; looking for trainers; and preparing the summer program schedule for TAYD.
