The Organization funded the operation and maintenance of a hospital in the Nuba mountains to include supplying medicines and medical supplies, staff salaries, and staff training. The Organization funded United States and foreign organizations to provide services to the people of South Sudan. The Sudan Relief Fund advocated for the people of South Sudan by raising awareness of their situation through mailings, videos, and public events in the United States.
