The Council replenishes the Center Petty Cash Fund as needed. In 2016 the Center Petty Cash Fund was used for programs, fundraiser expenses, food, holiday gifts for senior volunteers at the Front Desk and in the kitchen, appreciation gift cards for instructors of free classes, and a gift card for a staff member who retired. The Center is owned and operated by Howard County Government. The Council owns no property but uses property of the Center.

Part V. All Council assets are contained in the bank checking account. The Council owns no property and has no liabilities. All assets are designated for support of the Ellicott City 50+ Center.
