FROM SOWING, WEEDING, AND FERTILIZING TO PROCESSING AND TRANSPORTING PRODUCTS, THEY PLAY A VITAL ROLE IN FEEDING MORE THAN ONE BILLION PEOPLE. WE SUPPORT NETWORKS OF WOMEN FARMERS ACROSS THE AFRICAN CONTINENT-- GROUPS OF WOMEN WHO ARE DETERMINED TO CHANGE THE WORLD AROUND THEM.
