Hospital Visitation - MSA administers a program of certified volunteers who visit and assist at VA Medical Centers and state Veterans Hospitals throughout the United States. The program operates under the U.S. Veterans Administration Volunteer Services oversight, and provides more than 100,000 hours of volunteer services annually. This program is funded by donations from members of the Masonic fraternity. Donations are used to reimburse volunteers for expenses, fund events for veterans, and provide comfort items for veterans.

Education / Publications - Informational and educational items, including newsletters, books, brochures, digests, and other materials for the use in the non-profit Masonic Community, have been published by MSA since the origination of the organization in 1919.
