ADDITIONALLY, THE FOUNDATION PROVIDES SUPPORT FOR STUDENT-ATHLETE ACADEMIC ADVISING AT THE UNIVERSITY. THIS YEAR APPROXIMATELY 650 STUDENT ATHLETES AT THE UNIVERSITY OF VIRGINIA BENEFITED FROM THIS SUPPORT.
