The student body for the academic year ending in May 2016 consisted of 69 students, while the enrollment as of September 2016 was 55 students. Over 650 dancers were auditioned during a six week audition tour early in the year that included 12 different cities in the United States. Many of these were selected to attend intensive training sessions held in the summer at the Kirov Academy. Total enrollment in the summer sessions was 135 students.
