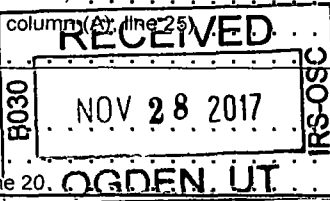

FEMINIST MAJORITY FOUNDATION (THE "FOUNDATION") IS TREATING LIBERTY MEDIA FOR WOMEN, LLC ("LIBERTY MEDIA"), A WHOLLY-OWNED SUBSIDIARY OF THE FOUNDATION, AS A DISREGARDED ENTITY PENDING THE IRS'S RESOLUTION OF LIBERTY MEDIA'S REQUEST, VIA FORM 8832, TO BE RECOGNIZED AS SUCH.

LIBERTY MEDIA FILED FORM 8832 ON AUGUST 11, 2016. LIBERTY MEDIA FILED THE FORM TO CONFIRM THAT ITS DISREGARDED ENTITY STATUS WAS NOT CHANGED BY ITS RECENTLY WITHDRAWN FORM 1023. LIBERTY MEDIA HAS BEEN A DISREGARDED ENTITY OF THE FOUNDATION SINCE THE FOUNDATION ACQUIRED LIBERTY MEDIA ON DECEMBER 31, 2001. ON AUGUST 28, 2015, LIBERTY MEDIA FILED A FORM 1023 WITH THE IRS IN ORDER TO RECEIVE EXEMPTION FROM CALIFORNIA STATE TAXES. AN ENTITY THAT CLAIMS TAX-EXEMPT STATUS BY FILING FORM 1023 IS TREATED AS HAVING MADE AN ELECTION TO BE CLASSIFIED AS AN ASSOCIATION. LIBERTY MEDIA DID NOT KNOW THAT FILING FORM 1023 CONSTITUTED A DEEMED ELECTION AND DID NOT INTEND TO MAKE SUCH AN ELECTION. UPON LEARNING OF THIS DEEMED ELECTION, LIBERTY MEDIA WITHDREW ITS PENDING FORM 1023 ON MAY 24, 2016 AND FILED FORM 8832. THE FORM 8832 INCLUDED A REQUEST FOR LATE ELECTION RELIEF, AS LIBERTY MEDIA SOUGHT CLASSIFICATION AS A DISREGARDED ENTITY EFFECTIVE AS OF AUGUST 28, 2015 SO THAT ITS DISREGARDED ENTITY STATUS WAS NOT DISRUPTED BY THE WITHDRAWN FORM 1023 FILING.

LIBERTY MEDIA HAS NOT YET RECEIVED NOTICE OF ACCEPTANCE OR NONACCEPTANCE OF ITS ELECTION FROM THE IRS. LIBERTY MEDIA HAS RESUBMITTED THE FORM 8832 TO THE IRS VIA THE TAXPAYER ADVOCATE SERVICE. IN ACCORDANCE WITH THE REQUIREMENTS FOR LATE ELECTION RELIEF, THE FOUNDATION HAS TREATED
