Form 990, Part III, Line 4a:

TRAINING International Programs CADCA's International Demand Reduction Program continued to expand during 2016. These international activities are in complete alignment with CADCA's mission to help create healthy, safe drug free communities globally. In 2016, CADCA continued work on a three year grant that was extended to a five year grant with the U.S. Department of State, Bureau of International Narcotics and Law Enforcement (INL). This work included the provision of training, technical assistance and ongoing support to, local communities, non-governmental organizations, local governments and other important groups in selected foreign countries to help them develop effective anti-drug community coalitions capable of achieving population level reductions in illicit drug use rates and associated problems. During 2016, CADCA's International Programs group continued its work on a sub-contract with Programa Compañeros, a non-governmental organization from Mexico, under contract through INL Mexico City to provide training and technical assistance in the cities of Durango, Hermosillo, State of Mexico, and Chihuahua. Additional training activities continued under a grant from the U.S. Department of State INL office in Brazil. Under this grant, CADCA provides training and technical assistance in the cities of Recife, Sao Paulo, and Rio de Janeiro, Brazil. CADCA's International Programs staff also participated in the 59th session of the United Nations Commission on Narcotic Drugs in Vienna, Austria. CADCA acted in a Special Consultative Status with the Economic and Social Commission of the United Nations. Through 2016, CADCA has helped develop 230 active international community coalitions worldwide. National Youth Leadership Initiative In 2016, CADCA's National Youth Leadership Initiative (NYLI) trained more than 900 youth and their adult advisors from across the country. Using a youth-led, team-teaching approach, the NYLI builds capacity to foster youth leadership in design, implementation and evaluation of action strategies addressing community problems through Youth In Action Projects. Seven evidence-based behavioral change strategies, emphasizing environmental modifications, are employed to effectively alter local conditions that contribute to substance use and its correlates. The NYLI model uses a public health approach to prevention. It is built on the framework of science-based community problem-solving processes researched and documented by the World Health Organization Collaborating Centre Workgroup for Community Health and Development at University of Kansas. This work has been calibrated for substance abuse by CADCA and institutionalized over 10 years through the National Coalition Institute (NCI), Coalition Academy and CADCA's Youth Programs delivery system. The NYLI is embraced by the White House Office of National Drug Control Policy (ONDCP), states and local communities. An independent evaluation conducted by Michigan State University found that participants trained by the NYLI experienced an increase in leadership competencies, community organizing, problem-solving abilities, current and future civic activism and civic and political engagement. Other trainings CADCA conducts training (non-National Coalition Institute training) primarily through established contracts to provide national, state and community level adult training events. These adult-fee-based training events are categorized as either Academies, Large Non-Academy projects, or Single Sites. During 2016, CADCA established contracts to conduct academies in Idaho, North Dakota, Tennessee, and the US territory of Guam. In addition, CADCA provided individual training events in numerous locations throughout the United States reaching over 2,500 coalition leaders and members. Non-Institute training events included work with the National Highway Traffic Safety Administration (NHTSA) Community of Practice, National Institute for Alcohol Abuse and Alcoholism (NIAAA), Drug Enforcement Administration (DEA), Wake Forest University, the state of Washington, the city of Philadelphia, and the District of Columbia Department of Health, to increase the capacity of coalitions and prevention leaders throughout the nation.

Form 990, Part III, Line 4b:

MEETINGS AND EVENTS National Leadership Forum CADCA's annual National Leadership Forum is the nation's largest training event for community anti-drug coalitions and other substance abuse professionals and volunteers. It also serves as CADCA's signature training, advocacy, and networking event. Over 3,000 substance abuse prevention and treatment specialists from throughout the U.S. and abroad attended CADCA's 27th annual National Leadership Forum, held in February at the Gaylord National Hotel and Convention Center in Maryland. Individuals from every U.S. state, the District of Columbia, one U.S. territory and several countries participated. The 2016 Forum theme was "Coalitions Monumental Impact" featured 73 training sessions and six plenary sessions and special events covering a wide range of topics from prescription drug abuse prevention to effective treatment strategies for diverse communities. The Forum also provided participants an opportunity to meet with U.S. Senators and Members of Congress during Capitol Hill Day. In addition, almost 400 youth participated in CADCA's signature youth leadership development program, the National Youth Leadership Initiative Mid-Year Training Institute. CADCA's annual Mid-Year Training Institute is the only intensive, four-day training designed specifically for community coalitions. The 2016 Mid-Year, held in Las Vegas, Nevada attracted almost 1,800 attendees. Included in the participants were almost 300 youth who attended CADCA's signature National Youth Leadership Initiative. There were also attendees from 16 other countries and two territories. The Mid-Year offered interactive half-day, 1-day and 2-day courses on everything from how to run a community anti-drug coalition to how to implement environmental strategies. Other Meetings & Events In addition to the Forum and Mid-Year, CADCA managed numerous events throughout the year including regional trainings, board meetings, and advisory meetings.

Form 990, Part III, Line 4c:

NATIONAL COALITION INSTITUTE CADCA's National Coalition Institute (the Institute) is a federally funded project to increase the effectiveness of community anti-drug coalitions throughout the United States and its territories. The Institute provides training and technical assistance, support for coalition evaluation and research, and develops and disseminates information to promote evidence-based programs, policies and practices. CADCA administers the Institute with a grant through the Drug-Free Communities (DFC) Support Act. Key federal partners are ONDCP and SAMHSA. Training, Technical Assistance and Outreach: The Institutes Training, Technical Assistance and Outreach department (TTAO) conducts several distinct types of face-to-face training in different locations and venues throughout the United States. The length and content varies. By providing a number of options, individual coalitions can seek the type and location of training that best meets their needs. The face-to-face training delivery system has been carefully developed to provide high quality and relevant training to a maximum number of coalitions in all areas of the country. Trainings can be tailored to meet the specific needs of coalitions in rural, frontier, urban, and inner-city communities. Technical Assistance (Coalition Hot Line): Any coalition or project officer on behalf of a coalition may request and receive unlimited no-cost individual technical assistance delivered over the phone or to individuals or groups through the Skype for Business distance learning system. A Technical Assistance Booth is provided during major training conferences such as the New Grantee Meeting, the National Leadership Forum and the Mid-Year Training Institute. This highly popular one-on-one meeting with the Institutes TA Manager, generates a significant amount of high-quality technical assistance on site and for future encounters and opportunities. Trainings - The Institute provides a variety of face-to-face trainings including the National Coalition Academy (NCA), state-level trainings, regional trainings, and training at the New Grantee Meeting for year 1, year 6 and mentoring DFC grantees. Trainings are designed to be particularly significant for coalitions with Drug Free Communities Act and the Sober Truth on Preventing Underage Drinking (STOP) Act grants. The Institute staff creates and distributes all training and workshop content, workbooks, PowerPoints, etc. for Institute-sponsored trainings. National Coalition Academy - In order to accommodate National Academy expansion to meet increased demand, TTAO collaborated with highly rated hotels to provide new Academy training facilities in 7 cities throughout the United States. These hotels provide rooms at a discounted rate for all training participants. In addition to lodging, grantees cover their cost for travel, transportation and meal expenses. In 2016, TTAO delivered training and technical assistance at several large training events such as the DFC New Grantee Meeting. TTAO also took the lead on the development and delivery of training sessions at CADCA's National Leadership Forum. Over four powerful days, more than 3,000 substance abuse prevention and treatment specialists from across the country convened for professional development. During this training event, participants gained insights from local, state and national experts on a wide range of substance abuse-related topics in more than 70 training sessions and plenary sessions. In addition, the Institute provided the content for the 2016 Mid Year Training Institute, attended by almost 1,800 substance abuse professionals and leaders. These signature training and technical assistance events provided opportunities for attendees to interact and exchange best practices with their peers who are facing similar challenges in their communities. CADCA is pleased to continue to partner with SAMHSA in supporting work that advances and strengthens the capacity of community coalitions. TTAO continues to develop its capacity to meet the growing demands of the field through its cultivation of a highly skilled training pool. The Institute continues a very successful Training of Trainers (TOT) certification process with selected trainer candidates. These candidates continued their certification process by being partnered with and mentored by current lead instructors to co-deliver NCA trainings. In addition, bi-monthly professional development webinars are conducted with all TTAO staff and consultants as a part of the TOT process. Customized Technical Assistance - Customized technical assistance provided an opportunity for assistance on any aspect of coalition operations that a coalition deemed relevant. Coalitions who took advantage of onsite customized technical assistance completed evaluations that were very positive. When asked to rate the usefulness of the content of customized technical assistance sessions, 100% of those who scheduled a session reported the level of usefulness at "a great deal." The DFC grantees in particular found the sessions to be extremely useful. The TTAO team continued to improve the existing Technical Assistance Reporting System (TARS). Each TA request made by a customer falls under its own "category/subtopic" based on SAMHSAs Strategic Prevention Framework and CADCA's Core Competencies. This allows the team to identify themes and areas of need for the prevention field. Each year these will be revisited and additional categories and subtopics will be added if deemed appropriate. Continuous progress was made on our aim to increase training transfer. After their Coalition Academy experience, individuals trained by the Institute are better equipped to transfer the knowledge when they return to their coalitions. This is a result of our intentional focus on training transfer which is fortified through our TA support system. One hundred seventy-nine coalitions (179) completed approved coalition products and participated in the National Coalition Academy graduation ceremony held in February 2016. Evaluation and Research: The Evaluation and Research (E & R) component of the National Coalition Institute works to support the data collection and evaluation efforts of member coalitions. Got Outcomes! remains one of the E & R signature projects in supporting coalition efforts. With this project, the best practices of coalitions are brought forward to both inform other coalitions work and to guide E & R technical assistance. Leveraging the latest research in prevention work and environmental strategies balances this work. In addition to bringing in research from universities and other organizations, E & R is currently directing the external evaluation of the Institute. E & R support national-level efforts in support of prevention by maintaining the tracking and reporting on the Institutes Government Performance and Results Act (GPRA) measures. Each of these parts of E & R related efforts will be addressed one-at-a-time. The Got Outcomes! Coalition of Excellence Awards attracted numerous applications in 2016 with awards going to the Hunterdon County Safe Communities Coalition, Building a Safer Evansville coalition, Vernon Coalition, and Janesville Mobilizing 4 Change coalition. These coalitions were recognized for implementing a comprehensive set of data-driven strategies that contributed to population-level reductions in their county-level substance abuse prevention outcomes. As in the past, technical assistance is tied directly to the Got Outcomes! review process. The winning coalitions received their award onstage during the Awards Luncheon at CADCA's National Leadership Forum at the Gaylord National Hotel and Convention Center in National Harbor, Md. They also shared details about their strategies and tips for coalitions during a workshop at the conference. The E & R team is continuing its work in bringing prevention research developments to member coalitions. The E & R webinar series includes content to prevent impaired driving AND IS funded by the National Highway and Transportation Services Authority. This work is being complemented by an ongoing annotated bibliography of peer-reviewed articles on community and coalition prevention efforts and by the anticipated agreement with Wake Forest University toward an external evaluation of the National Coalition Institute. CADCA is currently working with Wake Forest in an evaluation of social ordinance laws. Data tracking and detailed record-keeping of trainings and other Institute efforts has been the cornerstone for the Institutes ongoing success in meeting or exceeding its GPRA measures and the output targets. The careful coordination with the Training and Technical Assistance part of the Institute is a strong part of this success.

It is understood that within our field employees may be recognized as experts and given a financial stipend to speak. Cadca has capped the receipt of gifts at \$250.00. Employees are on the honor system to uphold Cadca's values in their everyday line of work. If given reason to suspect or indicate anything less than cadca's values, employees will be questioned by the CEO and CFO to determine if a breach of conduct has occurred and what action to take. Employees failing to adhere to the policy may be terminated. Money received is processed by the office manager, given to the CEO or CFO for financial approval and processed by the AR associate. Through these checks and balances, any financial amount received that would compromise cadca's integrity would be subject to further examination and questioning. Money received that has been deemed questionable by the CFO is presented to the CEO. The monies are returned with a polite letter explaining Cadca's Policy.
