RANKED CHOICE VOTING EDUCATIONFairVote had a successful year in 2016. Our program work increased public understanding of how electoral rules affect participation and our representative democracy. We engaged in research, analysis, communications, education, and advocacy within each of our three major program areas: education about ranked choice voting, education about representation of women in elected office, and general democracy work involving issues such as redistricting, presidential elections and the right to vote. Internally, we received the most revenue in our history, including quintupling our number of individual donors, and we had more staff than ever before. We secured significant general operating support grants from foundations. (Continued schedule O) Our major program focus was research and public education about ranked choice voting (RCV). RCV has important applications in nearly any context where voting occurs. This includes civic organizations and local governments choosing their leaders and strengthening voting rights for overseas voters in runoffs. These uses can ground support for extending RCV to practical statewide uses, such as replacing runoff elections, and using RCV for general elections and in combination with changes like open primaries and multi-winner districts. Extensive media attention to RCV in 2016, often featuring FairVote, helps indicate how RCV can be appealing in multiple ways and a subject of consideration for use in electing our nation's highest offices. Examples of 2016 program work in this include Outreach and education. Nationally, we partnered with leading organizations and individuals message about ranked choice voting and helped this voting method receive major media coverage. We wrote many opeds and contributed insights to opeds about RCV by the likes of former governor Howard Dean, former Congressman John Porter, and New America's Lee Drutman. FairVote and its Board talked about RCV and our reform work on such programs as Fox, NPR's All Things Considered and On the Media, and Freakonomics Radio. Our comments were featured in national media stories in Boston Globe, New York Times, Newsweek, Time, Wall Street Journal and Washington Post. We also advanced understanding of electoral reform and ranked choice voting in several states and cities. The FairVote Maine project engaged with large number of Mainers about RCV. Project staff and volunteers covered fairs and festivals, conducted demonstration elections in schools and senior centers, and they met people in their homes by phone and by door-to-door canvassing. We secured a close partnership with the League of Women Voters of Maine, helped generate more than 150 letters to the editor, and carried out directly or through regrants more than 80 community presentations. Our FairVote California project had an important launch in 2016, developing important collaborative relationships and making an immediate impact in assisting with Bay Area implementation of RCV in four cities using it in November 2016. We saw great value in its work, such as new handouts in English, Chinese, and Spanish, new relationships with many community organizations, and a strong media presence, including opeds on what voters need to know about voting with RCV in five Bay Area publications. We were an educational resource in a large number of additional states by providing information to local contacts, holding events, and doing speaking engagements. Ranked Choice Voting Resource Center. Our election administration project, with a six-member project team led by former North Carolina elections director Gary Bartlett, was launched, with overall goal of ensuring availability of RCV-ready voting equipment and educational resources for election administrators. In 2016 the Ranked Choice Voting Resource Center team. Contacted every major voting equipment vendor (and most minor vendors) to learn how jurisdictions can navigate RCV implementation on their legacy systems and the RCV-readiness of current and forthcoming equipment. Participated in multiple working groups working to update the voting system standards. Published www.rankedchoicevoting.org, an important new website where the team hosts educational materials and resources for election administrators and other audiences. Developed five educational modules for the team to present in webinars and at conferences and other events, and Funded a usability report that was drafted by Whitney Quesenberry of the Center for Civic Design, outlining best practices for designing ranked ballots, showing RCV election results, and educating voter Research. Under the direction of Dr. Sarah John, FairVote produced new important research projects. Among grant milestone projects, we published the 2016 edition of our biennial report on congressional elections. Monopoly Politics. The report demonstrates that congressional elections are shockingly uncompetitive, that partisan representation is unfairly skewed, that elections incentivize polarized partisan lawmaking, and that this is directly attributable to elections conducted by winner-take-all methods. We also conducted and released research project on redistricting reform and changes in competition, responsiveness and representation in U.S. legislative elections. A series of reports were published on state redistricting, and a chapter by FairVote's Rob Richie and Drew Spencer Penrose, grounded in this analysis, was published in March 2017 in the Rowman & Littlefield book Changing How America Votes. Harvard's Pippa Norris encouraged us to submit a paper proposal based on our analysis that then was accepted for a panel at the American Political Science Association in August 2017. We also produced important new research relating to money in politics and RCV. We also assembled our legal team of top-level election law professors that accomplished three goals: first, to serve as a standing case screening committee to make recommendations on investment in prospective and ongoing litigation, second, to provide help as we worked to develop a state constitutional audit, and third, provide their opinions on areas relevant to FairVote's missions in which they have key expertise. They complemented the work of an impressive team of pro bono attorneys at Hogan Lovells. We deepened our assessment of the relative impact of structural reforms and provided insights into the reform landscape in 50 states. An impressive group of seven leading scholars engaged in a multi-day retreat process to analyze reforms that will result in a new project release in 2017. We partnered with the College of William and Mary and a team of scholars on a YouGov academic survey of 1,000 likely Republican voters in February 2016 that included asking them to rank the presidential candidates and provide their views on electoral reform. The resulting report and data was featured in a National Press Club news conference and several publications.

And releasing the aforementioned reports on redistricting in the states. We also continued to provide elections services assistance to private organizations and businesses on a model scale.
